Extended abstract

Introduction: The Qur'an is the words of God and the result of all the guidance and educational needs of people from the time of revelation to the end of existence. The audience of this book is, first of all, the people of the Age of Revelation, to whom the verses of the Qur'an were revealed according to their positive and negative behaviors, and then the people after the Age of Revelation, who are obliged to read and act on the messages of the Qur'an. Studies within the Qur'an showed its gradual decline during the Prophet's (PBUH) mission as a matter of course. The verses of the Quran are divided into three categories, the principles of belief, moral aspects, and the verses of rulings. The investigation and analysis of the process of revelation of women-specific verses of al-Ahkam showed that the scope of the verses of al-Ahkam al-Nisa has taken a part of the Meccan and Madani surahs. The verses of al-Ahkam al-Nisa are scattered in Surah Makki and can be counted in an indirect way, even in the verses of al-Qasas. The propagation of Islam ended in Mecca. In Medina, the opportunity to socialize religious culture was provided, and with divine laws and the teachings of the Messenger of God (PBUH), the formation of a community of faith was provided in Medina. The revelation of the twentyeight surahs of the Qur'an in different places in Medina was deliberately overseeing the establishment of the religious community, organizing the necessary laws for it, in order to guide them towards the establishment of the central government and the modern Islamic society by removing the obstacles. Therefore, issues such as the specific verses of al-Ahkam for women, which were among the important topics that needed to be cultured, were explicitly addressed in its verses and became social culture and norms. In this research, the verses of al-Ahkam al-Nisa in Sur Madani, whose legal capacity is clear and obvious, were examined in the field of rulings specific to women. Discovering a network of women's verses and the evolutionary course of its topics for better and greater effects on the audience, is similar to these rulings.
